# Fundamental Step: Signing of Interinstitutional Agreements

We take the first step in the conservation of the basin and the wellbeing of its inhabitants.

To start deploying components 1 "Governance and capacity for informed and participatory decision-making on integrated watershed management," and 2 "Management of key interventions directed towards shared and integrated management of the basin", the project had to comply with three enabling conditions: the hiring of the Project Management Unit, the construction of the Project Operational Manual with the respective non-objection of the World Bank as implementing agency, and the signing of the Interinstitutional Cooperation Agreements in the four participating countries. The first two conditions had already been met, with only the signing of the agreements remaining.

We are pleased to report that Brazil signed the agreement on July 8, 2022, Colombia on October 31, 2023, and both Ecuador and Peru on April 25, 2024. These signatures mark an important milestone in the development of the project, allowing the start of the effective implementation phase.
